Module Aims

To introduce students to the clinical environment and build upon this experience through reflection. The students should be able to use knowledge, clinical reasoning skills and evidence-based practice to undertake physiotherapy assessment and utilise therapeutic skills in the efficient and effective application of physiotherapy management appropriate to their level of study and do this in a professional manner.

Outline Syllabus

Learning, reflection and experience appropriate to both a 3 week orientation to practice placement and a credit rated level 5 practice placement.

Module Learning Outcomes

On successful completion of this module, students will be able to...

- 1 Utilise a sound knowledge base to inform clinical reasoning.
- 10 Analyse, evaluate and progress treatment using appropriate outcome measures.
- 11 Incorporate patient education & self management into treatment.
- 12 Undertake practice that is ethically sound, with reference to confidentiality/consent and duty to protect.
- 13 Reflect on practice and outcomes of own interventions.
- 14 Complete tasks within an appropriate time frame.
- 15 Undertake a flexible approach to working practice in relation to others and the needs of the service.
- 16 Negotiate and develop learning strategies in collaboration with the Clinical Educator.
- 17 Complete timely, appropriate written communication including patient notes.
- 18 Enhance abilities to communicate and work with others by sharing information appropriately.
- 19 Behave in a professional manner in accordance with Health Professions Council (HPC) standards of professional conduct and ethics.
- 2 Integrate assessment findings with best available evidence.
- 3 Use knowledge, available evidence and assessment findings to plan and justify appropriate treatment.
- 4 Interpret assessment findings to produce an appropriate problem list.
- 5 Use awareness of cultural, sociological and psychological factors to modify approach to patients and carers
- 6 Integrate knowledge of own and other health worker roles into patient management plans.
- 7 Conduct a subjective examination, obtaining relevant information from the patient/carer and/or medical notes.
- 8 Structure and conduct an objective examination using appropriate tests/procedures.
- 9 Apply safe, effective appropriate treatment.

Learning, Teaching and Assessment Strategy

The students will revise appropriate material via self study regarding theoretical and professional issues before they embark on their professional practice experience. Their first professional practice placement, termed as Orientation to Practice (OTP), will be 3-weeks (108 hours). This is non credit rated and will allow the student to experience working in the professional environment before under taking credit rated placement. It must be passed before undertaking the 5 week (180 hours) credit rated placement. Students are required to meet the standards of professional conduct, performance and ethics as defined by the HPC 3.5. Failure to meet these standards on both placements will constitute a fail, with a capped mark of 35 on the credit rated placement.

Practice placement learning will bring together all the learning to demonstrate that all elements of the learning outcomes have been achieved.

Group and individual reflection following each placement is encouraged and facilitated using e-portfolio reflective tools.

Note: to meet professional requirements students must actually undertake 288 hours on placement.
