### Module Aims

To demonstrate the values & professional attributes associated with the NMC essential skills clusters when delivering nursing care within designated practice/care setting(s).

To enable the student to demonstrate their clinical decision making skills, therapeutic skills & approaches to health care interventions through the discriminate application of

evidence/theory when delivering nursing care for individuals with complex, challenging &/or rapidly changing needs within a multi-professional and multi-agency team approach.

## **Outline Syllabus**

## **Learning, Teaching and Assessment Strategy**

The key focus of this module is planned, supervised and supported clinical placement learning in a health care setting of one of our partner organisations (all learning outcomes). This will be supported by key lectures, seminars and tutorials which provide underpinning knowledge related to essential skills clusters, core and field specific skills and an opportunity to evaluate this knowledge for clinical decision making in complex, challenging or rapidly changing needs and the enhancement of clinical care and service delivery (LO 1.1, 1.2, 2.1, 2.2, 2.3, 2.4, 3.1, 3.2 and 3.3).

Students will be assessed formatively at the midpoint by the mentor and if additional support is required the link lecturer will be informed (all learning outcomes).

Summative assessment will also be undertaken in clinical practice by an assigned mentor

using a regionally developed Practice Assessment Document and Skills Log (all learning outcomes).
