Module Aims
The aim of this module is to enable the student to understand and gain experience of the application and delivery of a range of specialised methods and techniques from the blood sciences.

Outline Syllabus
Use of reference ranges during pregnancy, in neonates and in children. Tests of conception and pregnancy monitoring. Immunological mechanisms in implantation and pregnancy and protection of the neonate against infection. Antenatal screening tests for fetal abnormalities of haemolytic disease of the newborn, feto-maternal haemorrhage and fetal abnormality. Investigation of inborn errors of metabolism and biochemical abnormality in neonates and

children (hypoglycaemia hyperammonaemia, calcium and phosphate disorders, pubertal disorders). Tests for diagnosis and management of haematological malignancy in children
