To enable students to develop a critical understanding of contemporary issues affecting health and wellbeing. To enable students to develop skills required to undertake a literature review on a contemporary issue of student choice

Outline Syllabus
The module will address health and social care issues which are significant and contemporary at the time of module delivery and this will change from year to year. Advanced literature searching skills, selecting an appropriate topic, selecting and appraising the literature critically. Structuring and presenting the literature review, written presentation skills.

Learning, Teaching and Assessment Strategy

Research informed lectures will present key and contemporaneous topics and issues related to health, wellbeing and social care and will also address the principles and methods relevant to undertaking an independent study (LO 1a-b, 2a-b). Students will be asked to present an outline of the intended study and receive formative feedback to inform their on-going study. Use will be made of the VLE to complement lectures and will include course materials and links to relevant web-sites. Seminars and individual and group tutorials will provide tutor and peer support and feedback to develop students' skills and knowledge of undertaking a literature review (LO 1a-3b). Self-directed study will enable students to develop & expand their knowledge & analytical skills by undertaking guided and independent reading in preparation for tutorials and the assessment task. (LO 1a-3c).

All learning outcomes will be assessed by submission of the independent study and formative feedback will be available prior to final submission of the study.
