You will demonstrate safe and increasingly competent nursing practice, knowledge, skills and professional behaviours required at Stage 2 progression point.

Learning, Teaching and Assessment Strategy

This module will further develop your independence, professional care and knowledge (LO 2.1, 3.1, 3.4) and practical skills within the placement setting. You will undertake planned, supervised and supported practice placement learning and be prepared to participate, initiate and manage your knowledge and understanding of the determinants of health and well-being within the context of public health (LO 1.1, 1.2, 1.3) Lectures, seminars, group discussion and directed reading will build-on knowledge gained within the Improving Public Health module and applied to your field of practice and across professional boundaries(LO 2.2, 2.3, 2.4, 3.1, 3.2, 3.3). Small group, peer reviewed, simulated clinical skills teaching will enable you to practice skills in a safe and supported learning environment. Mapped NMC Essential Skills Clusters and Standards for Competence will assess your progress and learning and will inform your professional development & learning portfolio (LO 3.1, 3.4). The module will be delivered in collaboration with service users and practitioners within contemporaneous healthcare practice. The VLE will be used to provide access to online resources, lecture notes & external links to websites of interest. LOs 1.1, 1.2, 1.3, 2.1, 2.2, 2.3 3.1, 3.2 3.3, & 3.4 will be assessed by mode of assessment 1.
