Module Aims
The aims of the module are to examine the nature of the 'named' peoples of later prehistoric and Early Medieval Britain and Europe through their material remains and to challenge conventional understandings of these as unitary ethnic blocks.

Outline Syllabus
Taught sessions will form blocks structured around named 'peoples', including the ancient Celts, the Anglo-Saxons and the Vikings, though it will also touch on other groups including the ancient Greeks, Romans and Picts. Across the various case studies we will examine themes including the nature of cultural identity and ethnicity in the later prehistoric and Early Medieval periods, the changing nature of society, subsistence patterns, adaptation and change, the nature and impact of diasporas in non-literate periods, population assimilation/replacement and conflict, sustainability and resilience.

Learning, Teaching and Assessment Strategy
The module is taught through lectures (40 hours) divided into a series of blocks, each of which deals with a distinct prehistoric period/culture. Written feedback will be provided on the essays. During Directed Study hours students are expected to undertake reading to consolidate and expand on the content of formal taught sessions; research and prepare for assessments; revise material from formal taught sessions; and undertake specific elements of reading as directed. Assessment is by essay coursework. The essay will enable students to focus on one society in depth. Lectures delivered online.
