Module Aims
To provide the student with an understanding of the analysis of human skeletal material remains from mass disasters, the identification of victims of crime, and other types of casualties. The module will be taught through lectures and laboratory classes.

Outline Syllabus
The module builds on the basic knowledge acquired in Human Remains and Environmental Evidence. It will cover the history and development of the field of Forensic Anthropology: ethics and the retention of human remains; Identification of animal and human bone, minimum number of individuals (MNI); Sex assessment: Age estimation of sub-adults and adults; Metrical analysis and stature estimation; morphological variation and assessment of ancestry; Positive identification; Evidence of disease; Evidence of trauma.

Learning, Teaching and Assessment Strategy
Lectures. Practicals will reinforce lecture content through demonstration and study of human and faunal remains. Feedback: oral feedback will be given in lab session. Written feedback on coursework will be returned to students prior to the examination. Feedback on the formal examination papers will be made available in a timetabled feedback session. During Directed Study hours students are expected to undertake reading to consolidate and expand on the content of formal taught sessions; research and prepare for assessments; revise material from formal taught sessions; and undertake specific elements of reading as directed. Extensive reading lists will be provided. Online delivery of lectures planned initially, may be moved to campus dependent upon conditions.
