Learning, Teaching and Assessment Strategy

This module covers company law in a variety of contexts and introduces you to the key issues and debates in this area of law. Through lectures and seminars you will explore the law and discuss and debate issues arising from its application. On a blended learning model, lectures will deliver core content; providing students with the opportunity to acquire the information to enhance their knowledge and understanding of key issues. Sessions will include integrated online learning objects, which allow

students to assess their knowledge and understanding, This groundwork will be complemented by tutorials, both online and face to face, each of which will be based on a key contemporary issue in company law. The tutorials will provide a forum to analyse these issues, employing group work and case studies by students. All teaching and learning is supported by information (including the module handbook) provided on Canvas, our virtual learning environment

Active participation by all students is required in all tutorials and, where appropriate lectures, in order to engage with the module. During tutorials, verbal feedback will be provided to students regarding their work and there will be an opportunity to submit formative written work for feedback prior to the summative coursework that tests all five learning outcomes.
