## Learning, Teaching and Assessment Strategy

**Other:** This module will be delivered through participation in intrapartum midwifery practice. Students will work with an allocated mentor to develop the knowledge and skills required to achieve competence (appropriate to the level required on entry to the NMC register) in essential skills clusters (ESCs) in communication, normal labour and birth; initiation of breastfeeding and medical products management (NMC 2009) and complete the fetal monitoring package LO 2.1, 2.2, 2.3, 2.4, 2.5. Throughout the placement students will record and reflect on learning experiences in an e-Portfolio LO 1.1, 1.2, 1.3, 3.4.

**Tutorial:** The clinical mentor and the link lecturer will assess progress and provide formative feedback at a midway point.

**Clinical Assessment:** The final summative assessment is the culmination of a continuing assessment process. The student is graded on their achievement of module outcomes and essential skills, using a bespoke marking tool. Learning outcomes 2.1, 2.2, 2.3, 2.4, 2.5, 3.1, 3.2 and 3.3 will be assessed in practice (using marking tool criteria: team-working and communication, clinical skills and knowledge and professional and ethical practice).

Learning outcomes 1.1, 1.2, 1.3 and 3.4 will be assessed in the portfolio (using marking tool criteria: self-development and reflection).
