## Learning, Teaching and Assessment Strategy

Research informed key lectures will deliver core content; providing students with the opportunity to acquire knowledge and develop conceptual understanding. Some of these will be delivered face to face on campus, some will be delivered as a live (synchronous session and some as an asynchronous session ? meaning you can access the lecture at your own convenience) (LO 1, 2, 3, 5).

Seminars and group learning will be used to facilitate teacher/learner/ peer dialogue and inter-professional discussion and further develop and challenge conceptual understanding. Again some of these will be face to face, or as synchronous on line seminars (LO 1, 2, 3, 4, 5). Directed study provides students with the opportunity to undertake reading, participate in enquiry based learning, address individual learning needs and contextualise learning to the students own area of practice (LO 1). Formative feedback at individual and group tutorials will be through timetabled sessions, meetings can be arranged through electronic communication which will facilitate reflection and student self-assessment.

VLE will be used to provide access to online resources, lecture notes & external links to websites of interest. On-line discussion boards using VLE will promote group interaction and discussion of module content. Learning objects will involve allocated time within the module for students to engage with specific packages of learning using problem based learning or clinical skills resources. Practical sessions consist of opportunities to enhance acquisition of nursing procedures, leadership and management of care and regain competence (LO 3, 4).

Students will have a choice in the focus and type of written assessment for the programme, which will enhance and develop different academic skills in terms of report writing or reflective writing. This can help develop a new skill or relate the writing to a specific professional field of practice. The safe medicate exam will assess medicines management and numeracy for professional competence.

LO 1, 2, 3, 4 are assessed by either a report or reflective essay.

LO 5 is assessed by closed book safe medicate exam.

LO 4 is assessed through skills in practice by completion of a clinical practice document.
