Module Aims
Using a blended learning approach the aim of this module is to develop the knowledge and skills required to underpin the integrated care of an acutely unwell adult, using a person centred model that is safe and evidenced based. You will explore the challenges and opportunities in managing deterioration. The module will prepare you to interpret your own understanding and develop a critical perspective on local and national guidelines, taking into consideration the demographics and a cultural profile of the population cared for. Further develop your use in the application of digital literacy and its function within health care.

Outline Syllabus

Using appropriate and evidenced based assessment tools assisted by a digital platform, assess, plan, manage, deliver and review care for a range of physiological and psychological conditions which result in acute illness.

Monitoring and managing detection and prevention of a patient at risk of deterioration.

Understand the contribution of pharmacological, diagnostics and therapeutics within the management of the acutely unwell adult.

How to manage risk and understanding consequences of a fast paced front line care delivery.

How to manage realistic expectations, recognising the importance of resilience and understanding personnel responsibility.

Understand the use of local, national policies and strategies in their contribution to the management of the patient group in collaboration with primary, secondary and tertiary services.

Understand customs and practice which influence patient's decision making and how those map against local demographics, taking into consideration in a cultural and ethical context.

Learning, Teaching and Assessment Strategy

Using an innovative range of research informed learning and teaching strategies, supported by a range of digital technologies to facilitate your learning.

Using simulation, virtual patients and stage released patient journeys, involving patient and public involvement, as a way of introducing you to a range of conditions which may affect the acutely unwell adult. Supported by simulation (Artificial Intelligence technology) virtual patients and other digital platforms such as Canvas, Lab Tutor, and Kahoot. Some sessions will be delivered face to face; this will be identified on your personal timetable and within the Canvas module tile. On line sessions will be live, both synchronous and asynchronous, giving you access at your own convenience.

This will be complemented by theme based practical activities, supported by Team Based Learning, Problem Based Learning, seminars, debates and group learning to enable your learning in evaluating care, organisation and service delivery for the acutely unwell adult. . Some sessions will be delivered face to face; this will be identified on your personal timetable and within the Canvas module tile. On line sessions will be live, both synchronous and asynchronous, giving you access at your own convenience.

Virtual Learning Environments and digital technology will be used to provide access to online resources, reading lists, lecture notes and external links to websites of interest.

The assessment of the module is divided into two summative assessment tasks which assess the learning outcomes of the module. Each summative assessment is described as a component of assessment. To prepare you for the summative online practice assessment, you will have the opportunity to take a formative online practical assessment, which you will receive, feedback via Group or individual tutorials through electronic communications.

The summative written examination is a written examination, based upon a seen case study.

All assessments will be facilitated on line, synchronous.
