Learning, Teaching and Assessment Strategy

The module will be delivered using a blended approach. Learning packages will be available for students to complete at a time of their choosing with the caveat that where indicated this occurs before the taught session. Packages will contain videos, pre-reading, personal preparation tasks (e.g. preparing a CV, self-evaluation tools) and E-learning resources. Learning from these packages will then be explored, consolidated and expanded on using synchronous online lectures and workshops. Inclusion of clinical colleagues as external facilitators will ensure that the learning material is applied to current Occupational Therapy practice and facilitates the transition from student to practitioner. Tutorials will be used to support learning and facilitate both modes of assessment. Students will support all learning activities with evidence from a portfolio of evidence on going from the beginning of the programme. Assessment one will require students to select relevant evidence from this portfolio to demonstrate how they meet the Health and Care Professions Council Standards of Proficiency; this will assess LO's 1.1, 2.1, 3.1, 3.2. Assessment two requires students to engage in an interview situation; this will assess LO's 1.2, 2.2, 2.3, 3.3. Both elements must be passed.
