04	Communicate your questions, methodology, findings and arguments clearly in writing.

Learning, Teaching and Assessment Strategy
Lectures for this module will be held online and students will engage in weekly combination of online learning. The module includes a set of common lectures on research skills, research methods, tools and techniques and also ethical issues in conducting research including an understanding of sources of bias in research design (LO's 1, 2, 3). The Gender Labs will be held over two afternoons in career booster week. They will be held online and delivered synchronously and will consist of a mixture of briefing, facilitated breakout groups, lecture and Q and A, and workshops. Additional materials will be made available to access asynchronously Most of your work for this module will be self-directed and independent. The module will, however, provide a supportive structure, atmosphere and learning community for this work, with group sessions at key points in the process, one-to-one supervision, and mechanisms for peer feedback. The precise format of your dissertation will depend on the nature of your research and the chosen methodology. Each project will, however, include a clear articulation of research questions and objectives, critical engagement with relevant literature, a discussion of methodological issues (including a consideration of ethical questions where appropriate), and a presentation of outcomes. You will be expected to demonstrate your achievement of the module learning outcomes. The methodology appropriate to your research will be negotiated with your supervisor. Appropriate ethics approval must be obtained in accordance with the Division and Faculty ethics approval process (see handbook for details). Attendance is required at the Gender Labs and everyone is required to hand in a reflective research report, as this is important preparation for the independent enquiry aspect of researching a dissertation. It also introduces you to an important concept and its application which is of great relevance across the professional fields of peace and development
