Module Aims
The aim of the module is the production of a dissertation reporting empirical research, conducted under appropriate supervision. A subordinate aim is the consolidation, application and further development of knowledge and skills in research methods acquired from Stage One and Stage Two level modules. A final aim is the acquisition of in-depth knowledge and understanding of the area of psychology chosen by the student as the focus of the dissertation.

Outline Syllabus

All students will have access to individual support from their designated supervisor (or designated deputy), throughout Semester 1 and 2. The module will be introduced via a scheduled online lecture in Induction Week and further supported by a number of Learning Objects that will be available online for students to interact with. These will cover key aspects of doing empirical research of a qualitative or quantitative nature, including how to gain ethical approval. You will design and conduct the research independently under the guidance of your supervisor, with whom you will liaise regularly, these supervisions being your responsibility to instigate. Additionally, with the agreement of your supervisor you may approach other staff for advice as required by your research, such as technical support and subject specialism guidance. To comply with the British Psychological Society Code of Conduct all projects need to go through a process of ethical review before data collection can commence

Learning, Teaching and Assessment Strategy

The learning strategy is built around this being an independent piece of work conducted under 1:1 supervision, supported by an introductory lecture as well as Learning Objects placed online for you to interact with. This module is summatively assessed 100% through your dissertation, a written research report that assesses learning outcomes 1a; 1b; 2a; 2b; 2c; 2d; 2e; 2f; 3a; 3b; 3c; 3d; 3e; 3f; 3g. To support you to achieve well in this assessment, you are given three distinct opportunities to submit draft work via Canvas to receive formative feedback from your supervisor. Specifically, these opportunities are: in Semester 1, feedback on a draft of your Proposal and Ethics; early in Semester 2, feedback on a draft of your literature review, and finally later in Semester 2, feedback on a draft of your results/findings.

Ethical Review: To comply with the British Psychological Society Code of Conduct all students will make a formal ethics application via Canvas. This is a compulsory pass/fail exercise with no weighting towards your module result. All ethics applications will be reviewed and established as ethically sufficient before any data collection can commence: the divisional process for this ethics review is outlined in the module handbook. Failure to comply with ethical requirements will mean that your dissertation cannot be marked and will achieve a grade of zero.
