(3) Promote the dissemination of findings in formats suitable for a professional audience. (4) Foster the development of professional academic writing skills.

Outline Syllabus
Evidence based practice. The use of electronic databases for the identification of relevant literature. Frameworks for comprehensive search and retrieval of relevant literature. Overview of quantitative and qualitative research and data collection methods. comprehensive appraisal skills including; methodological issues, rigour, reliability and validity. Frameworks for comprehensive literature review and appraisal. Writing for publication. Time management and effective use of supervision. Critical thinking and reflective analysis. Presentation skills including style, editorial issues, getting messages across. Poster presentation skills (including use of powerpoint). Oral presentation skills (including use of powerpoint).

Learning, Teaching and Assessment Strategy
Research informed key lectures will deliver core content; providing students with the opportunity to acquire knowledge and an in depth awareness of different philosophical and methodological aspects of research and comprehensive literature processes (LO 1.2, 2.1, 2.2, 3.2, & 3.2). Seminars, group discussions and tutorials will enable students to apply this learning to their own understanding and examination of the evidence base for the students' named area of care (LO 1.1, 1.2, 1.3, 2.1, 2.2, 2.3, 2.4, 3.1, 3.2, 3.4 & 3.5). Directed study provides students with the opportunity to engage in self-directed reading, literature searching and the evaluation of findings related to practice (LO 1.1, 1.2, 1.3, 2.1, 2.2, 2.3, 2.4, 3.1, 3.2, 3.3, 3.4 & 3.5). VLE will be used to provide access to online resources, lecture notes and external links to websites of interest. 'Independent Study' consists of self-directed reading and analysis of the literature and evidence with opportunities for this to inform practice within own or other clinical areas (LO 1.2, 2.1, 2.2, 3.1 & 3.2). LO 1.1, 1.2, 1.3, 2.1, 2.2, 2.3, 2.4, 3.1, 3.2 & 3.3 are assessed by Mode of Assessment 1. LO 1.1, 1.2, 1.3, 2.1, 2.2, 2.3, 2.4, 3.1, 3.2, 3.4 & 3.5 are assessed by Mode of Assessment 2.
