Learning, Teaching and Assessment Strategy
On-line lectures (asynchronous) and class participation exercises (through seminars face to face & on-line) allow for development of cumulative knowledge and understanding of course content, along with directed study following guidance given in lectures and in the Module Handbook, whilst seminar and on-line tutorials allow extended time for the development, delivery and discussion of both formative and summative presentations for assessment. Both formative and summative assessments allow students to develop research and presentation skills relevant to future employment opportunities in the criminal justice and related sectors. Class discussions and engagement (on-line and in face to face seminars) in preparing and discussing the presentations provide an immersive introduction to the experience of presenting academic arguments and knowledge in a public setting. The subsequent development of the presentation into an academically-informed analysis provides the opportunity for students to deepen their theoretical understanding of the topics covered in the module.
