| <p>This module will be delivered through full participation in community and hospital based midwifery practice. An allocated clinical mentor practice supervisors, with link lecturer support, will supervise and advise the student as they manage a personal caseload of childbearing women. Additional clinical support on managing complex situations will be available from an allocated Supervisor of Midwives senior midwives.</p> <p>Throughout the placement students will record and reflect on learning experiences in a web-based ongoing record of achievement (ORA). The ORA must be submitted to the module workspace at the beginning of the placement and must be kept up to date throughout the module. (LO 1, 2, and 3).</p> <p>Tutorial: The Link Lecturer academic assessor will provide formative feedback on the ORA at the Intermediate point (LO 3.4)</p> <p>Clinical Assessment: The final summative assessment is the culmination of a continuing assessment process. The student is graded on their achievement of module outcomes and essential skills, using a bespoke marking tool. Learning outcomes 1.1, 1.2, 2.1, 2.2, 2.3, 2.4, 3.1, 3.2 , 3.3, will be assessed in practice (using marking tool criteria: team-working and communication, clinical skills and knowledge and professional and ethical practice, self-development and reflection). Learning outcomes 1.1, 1.2, 1.3, 2.1 3.4 will be assessed in the ORA (using SOHS portfolio level 6 marking tool).</p> <p>Completion of programme requirements which enable registration to the NMC register, in accordance with Directive 2005/36/EC of the European Parliament and of the Council (2005). This is a Pass/Fail assessment.</p> |
