Module Aims
The aim of this module is to develop a working knowledge of determinants of mental health across the lifespan. The aim of the module is to prepare to be able to demonstrate the ability to apply an evidence-based bio-psychosocial approach to mental health care. This will enable you to deliver high quality care in partnership with other professionals and service users and their families.

Outline Syllabus
Develop a working knowledge of the determinants of mental health during infancy considering infant mental health, attachment and play therapy. Understand the impact of adversity, painful experiences, and trauma in childhood. Understand the impact of Adverse Childhood Experiences and common childhood conditions upon mental health. Develop a working knowledge of the determinants of mental health during adolescence considering social, physical and emotional changes in young people, and contemporary challenges to wellbeing. Understand the theory related to eating disorders, psychosis, personality disorder, suicide, and self-harm. Develop a working knowledge of the determinants of the adult experience of mental health considering the perinatal period, addiction disorders, and mental health in the midlife. Develop a working knowledge of the determinants of the older adult experience of mental health considering the experience of aging, dementia, and suicide in the elderly. Field work will enable you to engage in interagency learning opportunities from third sector bodies, and input from service users will give you the opportunity to contextualise your learning in real life experience. (LO 1, 2, 3, 4).

You will be expected to utilise appropriate digital technologies and study skills to engage with additional resources directed by the module team, and in independently directing your own learning. Learning objects will involve allocated time within the module for students to engage with specific packages of learning (LO 1,2,3,4)

The module is summative assessment for the module is a single assessment task.

The exam tutorial will take you through the expectations of the Open Book examination, which is designed to create an enriched learning environment, offering you an opportunity to better understand and respond to the material presented in the teaching sessions.

The summative assessment is a written examination based around a seen case study or topic. An Open Book method will enable you to demonstrate a move away from memorised work to develop higher order thinking.
