You will undertake a placement within your chosen field of practice and will critically apply and evaluate underpinning theoretical knowledge by undertaking planned, supervised and supported practice learning experience and supported reflection opportunities throughout your placement. Demonstrating competency in nursing procedures taught in the university setting.

Medicines management and reflection on and in Practice.

Learning, Teaching and Assessment Strategy
You should engage positively in all practice experience learning opportunities, take responsibility and demonstrate increasing autonomy in informing your own learning and professional development. You should know who to access for support when needed. You will be taught and supervised in accordance with your individual learning needs, proficiency and confidence. At mid-point of placement you will have opportunity to share and reflect on your placement experience and learning with your peers and an academic Link Lecturer in a safe and supported environment. Continuous assessment is an integral aspect of learning and teaching in practice and you are expected to show evidence of consistent achievement during the placement. You will work with and receive written and verbal feedback from a range of staff including practice supervisors and practice assessors. You are required to critically reflect on your developing knowledge and practice. Assessment is structured and recorded within your ePAD (electronic practice assessment record). You will meet with your practice assessor/supervisor at the start, mid point and final week of Practice 6 to discuss your individual learning needs and progress. An action plan will be agreed and must be recorded in the ePAD at these points. Your practice assessor/supervisor and academic assessor will support and guide you towards successfully achieving the criteria set out in the Future Nurse: Standards of Proficiency for Registered Nurses and Standards for Education and Training (NMC 2018). Assessment of practice will be commensurate with Level 6 grading rubric in the ePAD. If you are unable to achieve any standards of proficiency through lack of opportunity then this must be clearly documented in your Electronic Ongoing Assessment Record. Successful completion of the Safe medicate digital package and online examination with a pass mark of 100%.
