Learning, Teaching and Assessment Strategy

Placement learning will be supervised and facilitated by PPEs. Research informed teaching and learning will ensure students engage in placement preparation and debrief packages/learning objects; including Mandatory Pre-Practice Placement Training will be included within these taught hours. De-brief will facilitate students to identify & record professional development within an e-portfolio, identifying future learning objectives and skills and attributes to utilise in an interview setting. Reflections will be completed before, at midway and on completion of the placement to identify learning. Resources to support learning will be available on VLE. All students will have contact with the University at the beginning and mid-point of the placement by either a visit or a telephone call or virtual touch base session as a minimum.

Formative and summative assessment will use the Competency Based Fieldwork Evaluation for Occupational Therapists (CBFE) completed by the PPE and clinical colleagues. The summative element is worth 100% of the mark allocation and is calculated using the CBFE rating scale conversion which will address all L.O.'s. Students will engage with service users, providing opportunity for clinical engagement, and development of their learning. Placement hours are normally calculated on a 37.5 hour week for the eight week duration of the placement, thus equalling 300 hours.
