| <p>Examination of how major foundational and post-foundational theories of international relations (including realist traditions, liberalism and neo-liberal institutionalism, constructivism and critical theory) have been debated and developed in recent academic literature. The module also introduces and examines additional theoretical approaches and how they can be applied, including rationalist theories of international relations, normative approaches and cognitive theories, theories of Strategic Interaction, domestic politics and International Relations. These theories are then critically examined in relation to their relative strengths and weaknesses, and their application by academics and policy communities to selected contemporary international challenges.</p> |
