| This module explores key concepts ideas and debates relating to processes of globalisation and the emergence of global institutions to govern these. You will examine the main contending theories which have been used to explain the emergence of global markets and the impact of these on ideas about development and on problems of social injustice, inequality and exclusion. We will explore key mechanisms in the historical formation of the global political economy and we will critically evaluate contending positive and normative claims about the nature of globalisation and global governance. We will conduct in-depth investigations of how global governance works in particular issue areas, for example the international governance of peace and security; aid and development; trade and investment; climate change adaptation and mitigation; and labour and migration. |
