Outcome Number	Description
1	Critically discuss the rationale for, plan, design and carry out a specific research project in the field of international nursing studies. Students will be expected to include their reasons for the professional interest in their research project's focus.
2	Demonstrate appropriate awareness and management of ethical dimensions in undertaking a specific research project in the field of nursing.
3	Produce a written account of their own specific research project undertaken including a critical and cogent account of its research methodology, design and data collection methods, means of data analyses, research findings, conclusions and how these may impact international nursing practice.

Learning, Teaching and Assessment Strategy

Face-to-face/online lectures: information will be presented and discussed with support of Powerpoint presentations. Face-to-face/online seminars and group discussions: learning through interpretation and critical application of information. Face-to-face/online tutorials will take place throughout the module, 12 hours of tutorials will be conducted on a one to one basis. The remaining 66 hours will be group tutorials.
