Module Aims
The aim of this module is to enable you to advance your nursing practice within contemporary health care settings. You will undertake a placement within your chosen field of practice and critically apply underpinning theoretical knowledge by undertaking planned, supervised and supported practice learning experience and supported reflection opportunities throughout your placement.

Outline Syllabus
You will receive an Induction to Practice 7 including: policy and protocols relevant to practice area and will include IT and systems training/digital technologies (by organisation) Understanding role and responsibilities: Future Nurse: Standards of Proficiency for Registered Nurses and Standards for Education and Training (NMC 2018); The Code (NMC 2018) including: professional code and values, being an accountable professional promoting health and preventing ill health providing and evaluating care leading and managing nursing care working in interprofessional teams, improving safety and quality of care and coordinating care for and with service users. Medicines management Critical reflection on and in Practice to inform ongoing professional development.

Learning, Teaching and Assessment Strategy
You should engage positively in all practice experience learning opportunities, take responsibility and demonstrate increasing autonomy in informing your own learning and professional development. You should know who to access for support when needed. You will be taught and supervised in accordance with your individual learning needs, proficiency and confidence. At mid-point of placement you will have opportunity to share and reflect on your placement experience and learning with your peers and an academic Link Lecturer in a safe and supported environment. Continuous assessment is an integral aspect of learning and teaching in practice and you are expected to show evidence of consistent achievement during the placement. You will work with and receive written and verbal feedback from a range of staff including practice supervisors and practice assessors. You will also be expected to seek written testimonies from service users. You are required to critically reflect on and discuss your developing knowledge and practice with your Practice Supervisor/Assessor. Assessment is structured and recorded within your ePAD (electronic practice assessment record). You will meet with your practice assessor/supervisor at the start, mid point and final week of Practice 7 to discuss your individual learning needs and progress. Your practice assessor/supervisor and academic assessor will facilitate your practice learning experience to enable you to work towards successfully achieving the performance criteria set out in the Future Nurse: Standards of Proficiency for Registered Nurses and Standards for Education and Training (NMC 2018). All required hours and standards of proficiency set out in the MYEPAD must be achieved before progression to registration. Whilst the NMC Standards of Proficiency for Registered Nurses and Standards for Education and Training (NMC 2018) will be assessed using the same rubric as the Practice 5 and Practice 6 you will demonstrate your deeper knowledge and understanding to your Practice Assessor through your ability to critically appraise and evaluate your own professional practice If you are unable to achieve any of the standards of proficiency through lack of opportunity then this must be clearly documented in your ePAD by your Practice Assessor and discussed with your Academic Assessor. In addition to being assessed in the practice environment, you will also be required to write a reflective piece which will critically appraise and evaluate your effectiveness in meeting the NMC performance criteria during placement, identifying learning priorities that will inform your future practice. This theoretical assessment is inextricably linked to practice and enables you to demonstrate a deeper and higher level of knowledge applied to your learning experience to inform your ongoing professional development.
